PETITION FOR PRELIMINARY INJUNCTION

AND NOW, come the Plaintiffs, who, by and through their attorneys, Quinn,
Buseck, Leemhuis, Toohey & Kroto, Inc., file the within Petition for Preliminary
Injunction and in support thereof aver as follows:

1. This action was initiated by the filing of a praecipe for Writ of Summons on
September 30, 2020.

2. Plaintiffs, Jamie and Ron McKalip, Barbra and David Vaughn, Thomas and Diana Wolak, and Kevin Hadley, are the parents and natural guardians of A.M, J.V., L.W. and J.H, ("Student Plaintiffs") respectively.

3. Plaintiff, Conneaut School District is a public school district and political subdivision of the Commonwealth of Pennsylvania with administrative offices located at 219 West School Drive, Linesville, Pennsylvania 16424.

4. Plaintiff, Slippery Rock Area School District is a public school district and political subdivision of the Commonwealth of Pennsylvania with administrative offices located at 201 Kiester Road, Slippery Rock, Pennsylvania 16057.

5. A.M. and J.V., are high school seniors at Conneaut Area Senior High School, which is located within Plaintiff, Conneaut School District.

6. L.W. and J.H. are a senior and junior in high school, respectively, at Slippery Rock Area High School, which is located within Plaintiff, Slippery Rock Area School District.

7. Defendant, The Pennsylvania Interscholastic Athletic Association, Inc. ("PIAA") is a corporation which governs and oversees interscholastic athletic competition between public and private schools located within the Commonwealth of Pennsylvania, with business offices located at 550 Gettysburg Road, Mechanicsburg, Pennsylvania 17055

8. Defendant, Pennsylvania Interscholastic Athletic Association District 10 Committee ("PIAA District 10") is the governing body for all interscholastic sports located within the geographical area of District 10 of the PIAA with business offices located at 68 Buhl Boulevard, Suite 3A, Sharon, Pennsylvania 16146.

9. Defendant, Michael Ferry, is the PIAA District 10 Golf Tournament Director.

10. For the purposes of interscholastic athletic competition, Plaintiff, Conneaut School District is located within the governance of PIAA District 10 as an AA Region Three school.

11. For the purposes of interscholastic athletic competition, Plaintiff, Slippery Rock Area School District, is located within the governance of PIAA District 10 as an AA Region Two school.

12. For the purposes of regional competition and qualifying for PIAA Boys Golf State Athletic Championship Tournament, PIAA District 10 has historically had golfers qualify through a series of mega-matches with average scores resulting in certain automatic bids, and with other qualifiers gaining the regional tournament through a qualifying tournament.

13. Prior to September 24, 2020, PIAA, by and through, PIAA District 10, permitted eight male qualifying golfers from Region Three, which includes Plaintiff, Conneaut School District, to participate and play in the PIAA District 10 Golf Championship.

14. Prior to September 24, 2020, PIAA, by and through, PIAA District 10, permitted nine male qualifying golfers from Region Two, which includes Plaintiff, Slippery Rock Area School District, to participate and play in the PIAA District 10 Golf Championship.

15. On or about September 24, 2020, and after the conclusion of the 2020 golf season for participating schools under PIAA District 10 governance, PIAA District 10

announced, without a rational basis, that rather than permitting eight qualifying males from within Region 3, which includes Plaintiff, Conneaut School District to participate in the Boys' Individual Golf Tournament 2020, it would only permit four qualifying male golfers to participate in said golf tournament. See, PIAA District 10 Golf Championship Conditions attached hereto, incorporated herein by reference, and marked as

EXHIBIT A.

16. On or about September 24, 2020, and after the conclusion of the golf season for those schools within PIAA District 10 governance, PIAA District 10 announced, without a rational basis, that rather than permitting nine qualifying male golfers from within Region 2, which includes Plaintiff, Slippery Rock Area School District to participate in the Boys' Individual Golf Tournament 2020, it would only permit five qualifying male golfers to participate in said golf tournament. See, PIAA District 10 Golf Championship Conditions attached hereto, incorporated herein by reference, and marked as **EXHIBIT A.**

17. As a consequence of the recent decision of PIAA District 10 to reduce the number of qualifying golfers, Student Plaintiffs cannot participate in the Boys' Individual Golf Tournament 2020, even though they would have qualified under the historical PIAA District 10 limits applicable to their respective high schools.

18. Student Plaintiffs, A.M. and J.V. are seniors at Conneaut Area Senior High School who would have qualified for the regional tournament had PIAA District 10 continued its historic practice of taking eight qualifiers to the regional tournament.

19. Student Plaintiffs, L.W. and J.H. are a senior and junior, respectively, at Slippery Rock Area High School, who would have qualified for the regional tournament

had PIAA District 10 continued its historic practice of taking nine male qualifiers to the regional tournament.

20. Plaintiffs have initiated the within action to compel Defendants to permit Student Plaintiffs to participate and play in the PIAA District 10 Golf Championships beginning on Friday, October 2, 2020 at The Country Club of Meadville.

21. Plaintiffs believe and therefore aver that Defendants' last-minute decision to modify the number of individuals who qualify for the Boys' Individual Tournament 2020 is unreasonable, was made in haste and is an abuse of discretion because it is arbitrary and capricious.

22. Student Plaintiffs will lose their opportunity to participate in the Boys' Individual Tournament 2020; and, as for the Student Plaintiffs who are seniors, will not have an opportunity to participate in said event again.

23. PIAA District 10 states, "The guiding philosophy is to establish representative tournament participation to all Regions of District 10." See, Policy statement attached hereto, incorporated herein by reference, and marked as **EXHIBIT A**.

24. PIAA District 10 is in breach of its "guiding philosophy" in that Student Plaintiffs are unable to represent their respective schools in the said golf tournament.

25. A court may grant a preliminary injunction when the moving party establishes the following elements: (1) relief is necessary to prevent irreparable harm to the movant; (2) the injunction will restore the parties to the status quo as it existed before the alleged wrongful acts; (3) greater injury would result from the refusal to grant

the injunction than from granting the injunction; and (4) the movant's right to relief is clear. All-Pack, Inc. v. Johnston, 694 A.2d 347 (Pa. Super. 1997).

26. The basic purpose of a preliminary injunction is to preserve the status quo pending final resolution of the underlying controversy between the parties. Fischer v. Dept. of Public Welfare, 439 A.2d 1172, 1174 (Pa. 1982).

27. Unlike a party seeking a permanent injunction, a party seeking a preliminary injunction is not required to establish his or her claim absolutely. Boyle by Boyle v. Pennsylvania Interscholastic Athletic Association, 676 A.2d 695, 699 (Pa. Commw. 1996) (affirming trial court's grant of a preliminary injunction against PIAA).

28. By preserving the status quo immediately prior to the alleged wrongful conduct of the party against whom the injunction is sought, the preliminary injunction attempts to avoid imminent, irreparable injury or gross injustice until the legality of the challenged action can be determined. Fischer, 439 A.2d at 1174.

29. Student Plaintiffs are entitled to protection under the equal protection clause of the Fourteenth Amendment and the actions of the PIAA and PIAA District 10 must adhere to a rational basis standard. Boyle by Boyle v. Pennsylvania Interscholastic Athletic Association, 676 A.2d 695, 702 (Pa. Commw. 1996).

30. Student Plaintiffs will be irreparably harmed if they are not permitted to participate in the Boys' Individual Tournament 2020 and their opportunity to participate will be forever lost.

31. Student Plaintiffs have participated on the golf team during the entire Fall 2020 season and it was not until 8 days before the District 10 Golf Individual

Tournament was scheduled to commence that Defendants arbitrarily and capriciously reduced the number of qualifiers to the extreme detriment of the Student Plaintiffs.

32. In balancing the equities, permitting Student Plaintiffs to play in the District 10 Golf Individual Tournament on October 2, 2020, will not unreasonably interfere with said golf tournament's operations or irreparably harm Defendants. Conversely, Student Plaintiffs' opportunity to play in said tournament will be forever lost, especially for the Student Plaintiffs who are seniors in high school.

33. Granting the injunction would return the parties to the status quo as it existed prior to September 24, 2020; namely the Student Plaintiffs would be permitted to play in said golf tournament since each qualified under the PIAA District 10 guidelines in effect prior to September 24, 2020.

34. Plaintiffs anticipate that Defendants will assert that the number of qualifiers was reduced due to the current Covid-19 pandemic. However, the reduction of numbers has no quantifiable relationship on the spread of Covid-19 as it relates to outdoor activities such as golf.

35. Indeed, the number of players and coaches permitted to interact on a single football field, many of whom come into direct, physical contact with each other outnumbers the amount of golfers on any one hole in the context of a District 10 golf tournament.


36. Further, Defendant, PIAA, has made no such draconian or arbitrary reduction in the number of golfers permitted to participate in golf related events for high schools.


37. Plaintiffs' right to relief is clear since Defendants' historical conduct has been to permit eight qualifying male golfers from Region Three and nine qualifying male golfers from Region Two to participate in the Boys' Individual Golf Tournament, and its recent decision to reduce the number of qualifying golfers is arbitrary, capricious and without adequate foundation.

WHEREFORE, the Plaintiffs respectfully request this Honorable Court to grant the within preliminary injunction and, accordingly, order as follows to: Student Plaintiffs are hereby permitted to play and participate in the Boys' Individual Tournament 2020 on October 2, 2020, and Defendants are enjoined from enforcing their restrictions as to these Student Plaintiffs, only.

**POLICY STATEMENT
FOR MEMBER SCHOOLS
WITH CONDITIONS OF ENTRY INTO
PIAA DISTRICT 10 CHAMPIONSHIPS**

PHILOSOPHY PREAMBLE AND CONDITIONS OF ENTRY

The District 10 member school Principals and Athletic Directors have a long established tradition and past practice of promoting a broad based and inclusive district wide guiding philosophy for selection of participating sports teams and individuals within the structure and format of all post - season tournament competition that has repeatedly been recognized and approved through their elected and appointed members of the District 10 Committee. The guiding philosophy is to establish representative tournament participation to all Regions of DISTRICT 10. All qualifying entries are invitations and as such can be rejected or revoked by a member school or the District Committee for the health, safety and welfare of the student/team participants including disciplinary sanctions.

DISTRICT 10 POLICY STATEMENT

(THIS STATEMENT IS IN EFFECT FOR ALL MEMBER SCHOOLS WITH REGARD TO CONDITIONS OF ENTRY INTO ALL PIAA CHAMPIONSHIP EVENTS)

PIAA District 10 Member Schools are not required to enter a Team into P.I.A.A. DISTRICT TEN CHAMPIONSHIP EVENTS. Entry and Participation by Member Schools in those tournaments sponsored by District 10 is totally voluntary. ENTRY of a Team or Individual Competitor by any Member School into a Tournament signifies that the member school accepts the conditions and provisions that are inherent with the Tournament rules, regulations, and guidelines. FURTHER, a Member School accepts the fact that the DISTRICT 10 CHAIRMAN, EXECUTIVE COMMITTEE, TOURNAMENT DIRECTOR, AND THE DISTRICT COMMITTEE reserves the right to make changes in the Management, Schedule, Sites, Dates, Times, and the Operations of Championships when, in their judgment, it becomes necessary to do so.

District 10 Golf 2020 General Information

- All Boys and Girls District 10 regular season Regional contests will consist of a 5-person team. Four of five scores count to determine the winner of the contest for boys and three of five scores count for girls.
- District 10 regions conducting an individual qualifier tournament may not play more than 18 holes.
- The District 10 individual tournament will be a 36-hole event.
- The District 10 team tournament will be an 18-hole event.

District 10 entries into the State Tournament

- For AA a maximum of 6 boys and 3 girls will qualify for the PIAA State Tournament on Monday October 19th at Heritage Hills Golf Course, York. For AAA a maximum of 1 boy and, 2 girls (from Sub-Region with D9 and D10) will qualify for the PIAA State Tournament on Tuesday October 20th at Heritage Hills Golf Course, York. Entries beyond the first qualifier must have a score no higher than 10 strokes above the qualifying score or the course rating.
- 1 boy's team and 1 girl's team in AA and AAA will qualify for the PIAA State Tournament on October 26th at Heritage Hills Golf Course, York, provided the team score is 400 or less for boys and 300 or less for girls.

District 10 Golf Tournament Specific Information

- **The District X Girls' AA and AAA Individual Golf Tournament** will be played as a 36-hole event at The Country Club of Meadville October 1 and October 3, 2020. For AA, top 12 and ties will play the second day. For AAA top 6 and ties will play the second day.
- **The District X Boys' AA and AAA Individual Golf Tournament** will be played as a 36-hole event at The Country Club of Meadville October 2 and 3, 2020. For AA, top 12 and ties will play the second day. For AAA top 6 and ties will play the second day.
- **Boys and Girls AA and AAA Team Championship:** District 10 Region Golf Champions will be invited to the District 10 Team Championship. The Boys Tournament to be played at The Country Club of Meadville Friday, October 2, 2020 in conjunction with day one of the individual tournament. A maximum of 5 players per team will play an 18-hole tournament with best 4 of 5 scoring. The Girls Tournament will be played at The Country Club of Meadville Thursday, October 1, 2020 in conjunction with day one of the individual tournament. A maximum of 5 players per team will play an 18-hole tournament with best 3 of 5 scoring. Winner to advance to the **PIAA State Championship Round.**
- **Individual Championships Entries:** All entries for the District 10 tournament from schools that participate in a Region must qualify either in a Region tournament conducted by your Region or are selected by the Region in some other manner.
 (See Appendix A)

A designated representative from each Region must e-mail the names of the individual qualifiers and region team championship players no later than the Tuesday before the tournament. For both boys and girls that date is September 29th

- **Independent Qualifiers:** (See Appendix C)
- **Practice rounds:** may be arranged by calling the Pro shop at The Country Club of Meadville (814) 724-7423. A coach or coach representative must accompany all players. There are attire restrictions at the courses. Call in advance.
- **Team Tournament Registration October 1, 2020 for Girls, and October 2, 2020 for Boys**
Registration: ALL COACHES are required to register 1 hour prior to first tee-time for rules and course conditions information, starting procedures and coaches assignments.
- **Individual Tournament Registration October 2 & 3, 2020 for Boys**
Registration will be from hour before. Day 1 – Tee Times starting at 9:30am. Day 2 - Tee time Start at 9:30 AM. All coaches will be assigned for the entire 18 holes.
- **Individual Tournament Registration October 1 & 3, 2020 for Girls**
Registration will be from hour before. Day 1 – Tee Times starting at 9:30am. Day 2 - Tee time Start at 9:30 AM. All coaches will be assigned for the entire 18 holes.
- **Entry Forms and Qualifying Information for Individual AND Team Tournament**
All leagues must use proper entry forms to be considered for participation in the District X Golf Tournament.
- **Separate Entry Form for Boys and for Girls**

Tournament committee reserves the right to determine the validity of entries and to adjust standards as needed in order to accommodate the limitations of the number of players for the course where the championship is being played.

Entry forms must be returned: **no later than September 29th, 2020**

- **Coaching Requirements**
Each golf participant must be accompanied by and supervised by a coach or a school appointed personnel from the sending school.
- **Miscellaneous Information**
 1. Be prepared to play in inclement weather.
 2. Caddies and motorized carts are not allowed on tournament days. Push carts are permitted.
 3. Please urge all golfers to be honest. USGA and local rules will prevail.
 4. Coaches will be assigned duties for the tournament.
 5. Food and beverages may be purchased at each course.
 6. The use of distance measuring devices is permitted.

GENERAL REGULATIONS DISTRICT X GOLF TOURNAMENT 2020

- Tournament Director—Michael Ferry
- 36 hole Medal Play for Individual Tournament. Stroke play rules apply. 18 holes for Team Tournament. Stroke play rules apply
- USGA rules govern play.

CONDUCT OF PLAYERS, COACHES, AND SPECTATORS DURING REGULAR SEASON AND POSTSEASON COMPETITION

Conduct of Players

- A two-stroke penalty shall be assessed for conduct unbecoming an interscholastic golfer. Such conduct shall include, but not be limited to, club throwing, defined as releasing a club in anger or in a manner to cause harm to any person or to a golf course; use of abusive language; willful acts which damage property or equipment of a golf course; or other unbecoming conduct, as determined by the Tournament or match/meet director.

Spectator Decorum

- Spectators will be permitted to walk on the course during competition. Riding carts for spectators may be used at the discretion of the golf course. Carts must remain on the cart path at all times.
- Spectators who choose to walk with the contestants, during competition, may do so under the following restrictions:
 1. DO NOT offer comments or make suggestions to the competitors. NO COACHING!
 2. DO NOT observe play closer than twenty-five (25) yards from the group of competitors being observed.
 3. DO NOT move or talk when a player is addressing the ball or making a stroke.
 4. DO NOT attempt to decide questions of fact nor attempt to apply the Rules of Golf.

Contestant's Attire

- All golf contestants are required to wear appropriate golf attire (i.e. school issued golf shirt and golf slacks or golf shorts). No exceptions are permitted. T-shirts, altered apparel, jeans, and advertisements (other than one visible logo/trademark not exceeding 2¼ square inches and not exceeding 2¼ inches in any dimension on a cap, visor, school issued golf shirt, and golf slacks or golf shorts) will not be permitted.
- The contestants' school name/nickname and/or school logo are permitted on the front and/or back of the school issued golf shirt and/or cap or visor. Sweaters and/or jackets will be permitted when necessitated by weather conditions. The use of tape on a cap or visor for the purpose of covering a logo/trademark, which does not meet the specifications described herein, IS PROHIBITED.

Ties

- ***Individual Tournament*** - If required, playoffs to determine a champion will be conducted immediately following the conclusion of the round. A first place playoff and a final qualifying position playoff (if necessary) will begin with an assigned hole, on a sudden victory basis. Ties for all other place finishers will remain as earned. In case of ties for any other spot for boys and for girls a scorecard playoff will determine position beginning with hole number 1.
- ***Team Tournament*** – If required, a playoff to determine a team champion will be conducted immediately following the conclusion of the round. Teams in the playoff will use 4 players (boys) or 3 players (girls), chosen by the coaches, from the day's play to break the tie. The playoff will begin on hole number 1 or the nearest convenient hole that is open. Players will all play the first playoff hole with the team scores being totaled at that point. Additional holes will be played as needed.

Appendix C

INDEPENDENT INDIVIDUAL QUALIFIERS FOR THE DISTRICT GOLF TOURNAMENT

PIAA POLICY CONCERNING QUALIFICATION FOR POSTSEASON COMPETITION OF INDIVIDUAL STUDENTS FROM SCHOOLS THAT DO NOT SPONSOR A TEAM DURING THE REGULAR SEASON

1. A student attending a member school that does not sponsor a Team may qualify for the District Individual Golf Tournament based on achieving a particular performance level. For golf, an independent golfer is required to have 9 verifiable scores that average within the range of qualifying scores of all others who have qualified for the tournament.
2. Producing a qualifying scoring average: A qualifying scorecard is one that has been verified by either (a) a PGA professional, or (b) a head coach of another school, if the student has participated as an independent in a Region match. All the scorecards of the independent golfer must be sent to the Tournament Director at least two weeks prior to the tournament. The Tournament Director will notify the independent golfer if he/she has qualified.

Note: A girl playing on a boys team seeking to qualify for the girls' individual tournament must use her scores from the team competitions to compute her average.

3. All students who are attempting to qualify to the District Tournament must meet all PIAA eligibility rules and requirements and must be accompanied and supervised by a coach from the member school that the student is representing, or by a full-time professional employee of the school or school district in lieu of a coach. The coach or full-time professional employee must be a properly designated representative of the school for the student, and that coach or full-time professional employee must be fully responsible for supervision of the student.
4. No Region will lose any district qualifiers due to the above students. The above players will be extra members of the District Tournament field of players.
